### **General provisions:**

### **Cancellation of certificate validity:**

The relevant national safety authority (the Railway Authority) or the certification body that issued this certificate may cancel the validity of this certificate if:

- there are justified doubts about the welding being carried out according to the relevant standards.
- there are justified doubts about the proper supervision of welding in accordance with the relevant standards.
- a certified welding supervisor is no longer available within the approved scope.
- valid certificates for welders and welding personnel are not available according to the relevant standards.
- welding within the scope of the relevant standards is being performed by welders and welding personnel who do not have the required qualifications.
- other conditions according to the relevant standards are no longer being met.
- the certification body is not permitted to conduct annual surveillance audits.
- the company waives the certificate

To cancel the validity of the certificate, the company must confirm the cancellation in writing to the certification body. The certification body will then notify the relevant national safety authority.

If the valid certificate is to be extended, it is necessary to apply to the certification body for an extension at least 2 months before the expiration date.
